Registration

Payment

Cancellations

The following penalties will apply on cancellation:

- 21+ days before a course commences = 20% of the invoice amount.
- 15-21 days before a course commences = 50% of the invoice amount.
- 1-14 days before a course commences = 100% of the invoice amount.

Non-attendance

- Non-attendance will be treated as a cancellation and all outstanding invoices will be due.

Transfers

In the event that a delegate can not attend the course and he/she would like to attend a future course, the delegate may transfer his/her registration conditional to the following:

- Transfers made 21+ days before a course commences will not be charged an additional fee.
- Transfers made 15-21 days before a course commences will be charged an additional 20% of the invoice amount.
- Transfers made 8-14 days before a course commences will be charged an additional 50% of the invoice amount.
- Transfers made 1-7 days before a course commences will be charged an additional 75% of the invoice amount.
- The transfer option only applies to delegates who are transferring to a different date for the same course.
- Transfers are valid for a maximum of 6 months in advance.
- The option to transfer can only be used once, after which non-attendance will be treated as a cancellation and all outstanding invoices will be due.
- If a delegate uses the transfer option, the original course invoice and the transfer invoice remain due, even if the transfer reservation is subsequently cancelled.
